- 1 That I am _____ (Name of applicant) S/o _____ Promoter/ Director/ Partner/ Proprietor/ Authorised person of _____ having its Registration no. _____ and Registered Office at _____ (office address of applicant).
- 2 I hereby make application and I am duly authorized in my own right/by management vide its resolution no. _____ dated _____ to apply and sign all required documents including this affidavit on behalf of Own/company/partnership firm/cooperative society etc. named as _____; and am fully aware of the facts relating to “Operational guidelines for the scheme “Operation Greens”-Short-Term Intervention”.
- 3 That the term and conditions of the above scheme of the MoFPI under which application is made by the applicant have been properly read and understood by me and I affirm that the application comply with all the terms and conditions provisions enshrined in the scheme guidelines.
- 4 It is certified that _____ (name of applicant) has not obtained or applied for subsidy for the same purpose or activity from any other Ministry or Department of the Government of India or State Government or their agencies.
- 5 I also solemnly affirm/undertake that the procurement of eligible crops have been made directly from farmers/FPO and their transportation and/or storage have been done in compliance with the Scheme Guidelines.

OR

I also solemnly affirm/undertake that I am a bonafide farmer/Group of farmers/FPOs and the eligible crops have been produced in the land possessed by me/us/members of FPOs respectively and their transportation and/or storage have been done in compliance with the Scheme Guidelines.

- 6 In case of concealment of any facts in this regard, the MoFPI would have right to reject/ cancel my application out right at any stage and recall the subsidy along with penalty.

- 7 I fully understand that 10% of the cases will be selected on random basis for undertaking audit. For such cases MoFPI or an agency authorized by MoFPI may call for original documents for verification. Failure to submit documents in original, I shall return the subsidy along with interest at the rate of 15% per annum (compounded on monthly basis), from the date of sanction of subsidy.
- 8 On examination of original documents, in case it is found that there is any discrepancy in the claim made and/or claim has been over-stated, I shall rectify such discrepancy and /or refund the excess claimed with interest at the rate of 15% per annum (compounded on monthly basis) on recoverable amount with one month of receiving communication in this regard from the MoFPI.
- 9 In case of fraud, misrepresentation/misdeclaration, falsification and fabrication of documents or other wilful default would be dealt as per penal provisions of the relevant Criminal and Civil Law(s).
- 10 I also undertake that all the information furnished in the application with respect to the eligibility conditions, etc. are true and correct to the best of my knowledge and belief and nothing material has been concealed therefrom.
