




**Gist of decisions taken by the Approval Committee (AC) constituted under the scheme of Cold Chain, Value Addition and Preservation Infrastructure in its meeting held on 08.11.2013.**

1	Final Approval to remaining proposals received against the EOI dated 07.05.2012 for setting up of cold chain projects	AC accorded final approval to the following proposals: 1. The Khammam District Cooperative Marketing Society Ltd. 2. Washington Cold Storage 3. Suyojit Infrastructure Pvt. Ltd. 4. Resource Food Pvt. Ltd. 5. Swaraj India Industries Ltd.
2	Request of M/s Dodla Dairy Ltd. to re-consider the decision of cancelation of the financial assistance to the project.	AC decided that the PMA may conduct a site visit to verify the physical progress of the project and also to verify the present expenditure on the project against the approved means of finance and to submit a report. The AC also decided that the final decision on the matter will be taken in the next AC meeting after taking into consideration the progress of the project based on the PMA's report.
3	Request of M/s Associate Action for Progressive Development Society for extension of timeline till 30.01.2014 to complete the project.	The AC, decided to grant extension of timeline till 30.01.2014 for completion of the project and submission of the documents for release of 3 <sup>rd</sup> instalment of the approved grant.
4	Request of M/s Shimla Horticulture for extension of timeline till 29.11.2013 to complete the project	AC decided to grant extension of timeline till 29.11.2013 for completion of the project and submission of the documents for release of 3 <sup>rd</sup> instalment of the approved grant.
5	Request by M/s Tuljabhawani Cold Storage Pvt. Ltd. for reconsideration of the ineligible proposal for integrated cold chain	the AC, after detailed deliberation, decided not to re-consider its earlier decision of rejecting the proposal of the applicant on grounds of non submission of the net worth certificate along with the proposal and directed that no further representation may be entertained from the promoter on this subject
6	The proposal of M/s Magnum Estate Limited, Bhubaneswar, Odisha received against the EOI dated 07.05.2012 for setting up MOFPI supported cold chain project.	In view of the fact that the applicant has expressed its inability in implementing the project as per the timelines prescribed in the scheme guidelines, AC decided to reject the proposal of M/s Magnum Estate Limited, Bhubaneswar, Odisha received against the EOI dated 07.05.2012



7	The proposal of M/s Aalishan International Pvt. Ltd., Rudrapur, Uttarakhand for change of location	AC approved the change in location of the project to Village Anandpur in Tehsil Kichha, District Udham Singh Nagar from the earlier location of Village-Kolra in the Tehsil Kichha, District Udham Singh Nagar.
8	Inkal Ventures Private Limited, Kochi, Kerala – request for the extension of the time line for completion of the project	AC directed the PMA to conduct a site visit to verify the physical progress of the project and also to verify the present expenditure on the project against the approved means of finance and to submit a report. The AC also decided that the final decision on the matter will be taken in the next AC meeting after taking into consideration the progress of the project based on the PMA's report
9	Proposals received against the EOI dated 7.05.2012 and pending for final approval or issue of approval letters due to incomplete documentation	<p>AC decided that a notice may be given to the following two applicants asking them to submit the required documents within one month failing which these projects may be rejected:</p> <ol style="list-style-type: none"> <li>i. Ishvakoo India (P) Ltd., Guwahati, Assam</li> <li>ii. Fresh Food Processing, Hisar, Haryana</li> </ol> <p>AC also decided that in the following 6 proposals which were finally approved by the AC but approval letters could not be issued because of non submission of revised documents/ information regarding revalidation of term loan, change in constitution of the applicant firm, means of finance, etc., the promoters may be given one month by way of notice to submit the wanting documents/ information failing which these projects may be cancelled:</p> <ol style="list-style-type: none"> <li>i.
