Vacancy Circular

Subject: Filling up of 01 post each of Director and Joint Director on deputation basis in the Fruit and Vegetable Preservation (F&VP) Cadre of Ministry of Food Processing Industries -reg.

This Ministry invites applications for filling up of one post each of Director, Group 'A', Gazetted (Pay Level-13) and Joint Director, Group 'A', Gazetted (Pay Level-12) in the Fruit and Vegetable Preservation (F&VP) Cadre of Ministry of Food Processing Industries from the eligible officers under the Central/State Governments/ Union Territories/ Recognized Research institutions/ Public Sector Undertakings/ Semi-Government/ Autonomous/ statutory organizations having the qualifications and experience as mentioned in **Annexure-I**.

2. The period of deputation would be initially for 3 years, which may be extended as per DoP&T guidelines. The term of deputation including pay of official during the period of deputation will be governed by provisions laid down in the DoP&T O.M. No.6/8/2009-Estt(Pay II) dated 17.06.2010 and other orders/guidelines issued in this regard, from time to time.

3. The period of deputation in another ex-cadre post held immediately preceding this appointment in same or some other organization/Department of the Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by Deputation shall not be exceeding 56 years as on the closing date of the receipt of application.

4. The vacancy circular is being published in the Employment News shortly. It is requested that the application of the eligible and willing officers and who can be spared immediately, may be forwarded in the prescribed proforma (**Annexure-II & Annexure-III**) along with copy of APAR for the last five years, Vigilance Clearance, Cadre Clearance and integrity Certificate Statement showing major/minor penalties, if any, imposed on the officer during the last ten years.

5. The applications complete in all respect should reach within 60 days from the date of the publication of the advertisement in the Employment News and should reach the **Under Secretary(Admin), Ministry of Food Processing Industries, Panchsheel Bhawan, August Kranti Marg, New Delhi- 110049.**

6.
