

**Minutes of the Meeting of Inter-Ministerial Approval Committee
under the Integrated Cold Chain & Value Addition Infrastructure Scheme
held on 17.08.2021**

MINUTES

The meeting was held under the Chairmanship of Hon'ble Minister, FPI to consider the miscellaneous matters under the Integrated Cold Chain & Value Addition Infrastructure Scheme.

2. Members of the IMAC and PMAs (GT, PwC & SIL) attended the meeting.
3. At the outset, Joint Secretary, FPI welcomed the participants and intimated the purpose of the meeting.
4. Detailed presentations were made by the Joint Secretary, FPI on the proposals. The agenda item wise recommendations of the Mission are as under:

Agenda-1 – Ratification of Decisions taken on File

IMAC considered the **eight (08) cases** where decisions were taken to allow withdrawal of projects for the reasons mentioned against each of the projects listed in **Annexure-I**.

IMAC also considered the **two (02) cases** of cancellation of the projects – one for submitting forged documents and the other where project has not been implanted in terms of the extant guidelines/approval letter.

IMAC ratified the decisions taken in these ten (10) cases [List at **Annexure-1**]

Agenda-2 – Withdrawal of Projects

IMAC noted that the project **M/s Far n Beyond, Haridwar, Uttarakhand**, an Irradiation Sector Project [approved on 31.03.2021 with Grant – Rs.10 crore] has submitted request for withdrawal vide communication dated 26.07.2021 as they are not able to comply with 30/90 days conditions.

IMAC also noted that another project **M/s Swathi Hatcheries, Dindigul, Tamil Nadu**, a Poultry sector project [approved on 28.09.2020 with Grant – Rs.10 crore] has also submitted request for withdrawal vide communication dated 16.08.2021 as they are not able to comply with 30/90 days conditions.

IMAC approved the withdrawal of these two projects.

IMAC was informed that “approval letters” to the two (02) waitlisted projects be issued against these cancellations as per the approval given by the IMAC dated 26th Mar 2021. IMAC consented to this proposal.
