OFFICE MEMORANDUM

Subject: Constitution of Approval Committee under the provisions of Production Linked Incentive Scheme for Food Processing Industry - regarding

In pursuance of Government decision, the Ministry of Food Processing Industries (MoFPI) has issued detailed operational scheme guidelines on 2nd May, 2021 for the implementation of Production Linked Incentive Scheme for Food Processing Industry (PLIS FPI). Under the scheme, sales-based incentive would be extended to large companies in selected product segments, to SMEs on manufacturing & sales of innovative/ organic product and grant to food processing entities on Branding & Marketing expenditure abroad. **A copy of the scheme Guidelines is attached for reference.**

2. As per the provisions of clause 14.1 of scheme guidelines, a Committee is required to be constituted by the Ministry, under the Chairmanship of Hon'ble Minister, FPI for taking necessary decisions within the mandate of the Ministry. Accordingly, the following Committee is constituted:

1	Hon'ble Minister (FPI)	Chairman
2	Hon'ble MOS(FPI)	Member
3	Secretary, FPI	Member
4	AS&FA, MoFPI	Member
5	Additional Secretary/ Joint Secretary –in-charge PLISFPI	Member

3. The Terms of Reference (ToR) of the Committee would be:

(1) Taking necessary decisions within the mandate of the Ministry viz approval of scheme Guidelines and their amendments including eligibility criteria, selection criteria, composition of products in different Segments, inter-component/ segment allocation of outlay, minimum required growth rate to become eligible for incentive;

(2) Fix/ relax norms on number of companies, selection of Applicants, sanction & release of funds as incentives within the approved outlay


4. The Committee may co-opt any other Expert/ Member, as may be considered necessary. The term of constitution of the Committee shall be for a period of two years or until further order, whichever is earlier.

5. The Committee shall make its own procedure for conducting its business and shall meet as frequently as warranted.

6. The Committee shall be assisted by the Project Management Agency (PMA) in conducting its business and the PMA shall furnish all information as required by the Committee to facilitate its deliberations.
