- 2. The Technical Committee shall also function as Technical Committee (or by whatever name it is called) for the purpose of projects sanctioned by the Ministry from time to time under guidelines issued earlier in respect of above-mentioned schemes.
- 3. The following shall be members of the Technical Committee:
  - (a) Additional Secretary/ Joint Secretary (PMKSY), MoFPI Chairperson
  - (b) Chairperson, National Bank for Agriculture and Rural Development (NABARD) or his/ her nominee as Financial Expert Member
  - (c) Chairperson, National Dairy Development Board (NDDB) or his/ her nominee for Dairy Sector Member
  - (d) Chairperson, Agricultural and Processed Food Products Export Development Authority (APEDA) or his/ her nominee for F&V and Meat Sector Member
  - (e) Chairperson, Marine Products Export Development Authority (MPEDA) or his/ her nominee for Marine Sector Member

- (f) Managing Director, National Horticulture Board (NHB) or his/ her nominee for Fruit & Vegetable Sector Member
- (g) Managing Director, Small Farmers' Agri-Business Consortium (SFAC) or his/ her nominee Member
- (h) Director, Bhabha Atomic Research Centre (BARC) or his/ her nominee for Irradiation Sector Member
- (i) Director, NIFTEM Kundali or his/ her nominee Member
- (j) Director, NIFTEM Thanjavur or his/ her nominee Member
- (k) Representative of relevant State Government(s) Member
- (I) Director/ Deputy Secretary, IFD, MoFPI Member
- (m) Director/ Deputy Secretary, PMKSY, MoFPI Member Secretary
- 4. The terms of reference of the Technical Committee shall be as under:
  - (a) Scrutinize applications (received against Expression of Interest floated by the Ministry) with respect to prima facie eligibility based on the eligibility criteria for the schemes.
  - (b) Evaluate the applications, inter-alia, on the basis of technical parameters as well as assessment criteria of the schemes.
  - (c) Recommend eligible applications to the Project Approval Committee for consideration of grants-in-aid.
  - (d) Any other related work assigned by the Ministry.
- 5. The chairperson of the Technical Committee may co-opt additional members on need basis.
- The Committee shall hold meetings at least once every month.
